ACH: If paying by automated clearinghouse (ACH), an electronic debit from your checking account, you must complete and include the ACH Authorization Form, which authorizes us to make a **one-time debit** against your checking account. We will initiate the transaction in United States Dollars (USD). If your company or bank is not located in the United States, you may be subject to exchange rate fees or other surcharges associated with an international transaction. Such fees and surcharges are out of our control.


